**New Resident Report** – Ron Cicchini reported that there have been no new residents for him to contact since the last meeting.

Lake Management Report – Rich Maxwell reported that he has received an accounting of the special assessment money from Professional Lake Management. His committee will be in contact with PLM and Paw Paw Township to evaluate how these costs have been spent and what costs are expected for the last two years of lake treatment and testing. Our lake has responded so well to the initial lake treatment, to manage the Eurasian Milfoil, only a spot treatment has been needed the last two years. The money that is not used may be rolled into the next contract with PLM. Rich also reviewed the E coli report for this year and discussed the concentration numbers at were given for the different test sites around the lakes.
