WHO NEEDS TO TAKE A BOATER SAFETY COURSE?

Michigan conservation officers and Michigan county sheriffs encourage all persons operating boats in Michigan to enroll in a boating safety course.

Personal Watercraft

Those less than 14 years of age may not legally operate a PWC.

Those 14 and 15 years of age may operate a PWC legally only if they have obtained a boating safety certificate and:

- He or she is accompanied on board by his or her parent or legal guardian or by a person at least 21 years of age who has been designated by the parent or legal guardian or:
- Persons born after December 31, 1978 shall not operate a personal watercraft unless they obtain a boating safety certificate.
- He or she is operating or riding the PWC at a distance of not more than 100 feet from his or her parent or legal guardian or from a person at least 21 years of age who has been designated by the parent or legal guardian.

Those at least 16 years of age and born after December 31, 1978, may operate a PWC legally only if they have obtained a boating safety certificate.

Those born on or before December 31, 1978, may operate a PWC legally without restrictions.

LITTLE THREE MILE LAKE AND PORTION OF THREE MILE LAKE – R281.780.2

HIGH-SPEED BOATING AND WATER SKIING PROHIBITED.

- 2. On the waters of Little Three Mile Lake and on that part of Three Mile Lake south of the south eighth line of section 21, T3S, R14W, Van Buren county, state of Michigan, no operator of any motorboat shall:
- (a) Operate such motorboat at high speed.
- (b) Have in tow, or shall otherwise assist in the propulsion of, a person on water skis, water sled, surfboard, or other similar contrivance.

RUSH LAKE AND THREE MILE LAKE – R281.780.1 – WATER SKIING HOURS.

 On the waters of Rush Lake and Three Mile Lake, Van Buren County, state of Michigan, no operator of any motorboat shall have in tow, or shall otherwise assist in the propulsion of, a person on water skis, water sled, surfboard, or other similar contrivance during the period from 7:30 p.m. to 11:00 a.m. of the following day.

GOVERNOR SIGNS BILL TO END "POP UP" PROPERTY TAX INCREASE FOR CLOSE RELATIVES

Good news coming out of Lansing for real estate owners wishing to transfer their home and/or real property to a spouse or child. On December 31, 2012,

Governor Rick Snyder signed enrolled House Bill No. 4753 which amends the General Property Tax Act of 1893 (Public Act 206), to allow property transferred to a person related by blood or affinity to the first degree to retain its current taxable value. The newly revised law will allow real estate property owners to avoid the property tax re-valuation, known as the "pop-up tax," previously in effect when real property was transferred from one spouse to another or by a decedent to a surviving spouse. A first degree blood relation would include the spouse and children, and a first degree affinity would include stepchildren.

Under the old law, when a piece of real estate is transferred to a new owner (including family members), the taxable value generally "uncaps" to the true value of the property. Once you own a piece of real estate the taxable value cannot increase from one year to the next by more than 5% or the rate of inflation, whichever is less, until that real estate is transferred to a new owner. The new law will make transferring a cottage or lakefront home, for example, more affordable for the close family recipients of the real property by maintaining property tax assessments at the lower levels "enjoyed" by the previous homeowner.

- Hey, thanks for letting me use the bathroom when I was working in your yard last week. While I was in there, I unlatched the back window to make my return a little easier.
- Love those flowers. That tells me you have taste...and taste means there are nice things inside. Those yard toys your kids leave out always make me wonder what type of gaming system they have.
- 4. Yes, I really do look for newspapers piled up on the driveway. And I might leave a pizza flyer in your front door to see how long it takes you to remove it.

- 5. If it snows while you're out of town, get a neighbor to create car and foot tracks into the house. Virgin drifts in the driveway are a dead giveaway.
- 6. If decorative glass is part of your front entrance, don't let your alarm company install the control pad where I can see if it's set. That makes it too easy.
- 7. A good security company alarms the window over the sink. And the windows on the second floor, which often access the master bedroom and your jewelry. It's not a bad idea to put motion detectors up there too.
- 8. It's raining, you're fumbling with your umbrella, and you forgot to lock your door understandable. But understand this: I don't take a day off because of bad weather

DEQ permitting restrictions, national holidays, and/or weather conditions may influence the timing of treatments throughout the qqYear season. PLM treats each lake according to a schedule or season plan, established with the cooperation of your lake association, lake board or residents on the lake. The treatment schedule is approximate. Please watch your shoreline for the posting of the 8.5x11 inch, yellow or green signs. The signs will indicate the date of the treatment, the products used, and any restrictions on the use of treated water for swimming, watering lawns, etc. The property owners in this area are planning to have the waters chemically treated to control lake weeds and/or algae. This notice is being circulated in accordance with Department of Environmental Quality (DEQ) procedures. Below is a list of herbicides that <u>may</u> be applied to the lake and the associated use restrictions. On the day of treatment, signs will be posted along the shoreline within 100 feet of treatment areas that indicate what products were used and specific water use restrictions that apply:
