
#### The Drain!

While it may take some time to see lake recede this new drain will essentially set the new MAXIMUM lake level so we'll never have to worry about the flooding we've seen the last couple of years!



#### **Swim Raft**



#### **Golf Cart Regulations**

#### Can I drive my golf cart around the lake?

This past year the lake association got some questions regarding golf cart usage on the roads around the lake. Of course the association does not set any of these "rules" or regulations but we wanted to let everyone know those guideline for those who are interested! Our township hasn't added additional ordinances since the state quidance was updated 3-19-2019 so generally it is legal if follow

the below

Here's the basics

An Operator

- ☐ Must be at least 16 and have a valid driver's license.
- ☐ Must comply with signal requirements.
- ☐ Must ride as far to the right as possible.
- ☐ Is not required to wear a helmet. Golf Carts
- ☐ Shall not be operated on sidewalks.
- ☐ May not pass between lines of traffic.

- ☐ May travel at a maximum speed of 15 MPH.
- ☐ May not be operated in the time period 1/2 hour before sunset to 1/2 hour after sunrise.
- ☐ Are only permitted to operate on streets that are 30 MPH or less



#### Are there any regulations regarding the placement of swimrafts?

To help clarify some questions this past year regarding swim-rafts we're providing some basic guidance based on MCL 324-80163 the state regulatory statue addressing hazards of navigation and recently expounded upon the The Michigan Riparian Magazine.

-Seasonal Swim Rafts do NOT generally require a state permit as long as they are not for commercial use.

-HOWEVER any <u>permanent</u> <u>swim rafts</u> that would stay out year round do require a permit per MCL 324.30103

Should/Can a swim raft have lights? There is not clear guidance on this issue it would depend on if the lights are causing a hazard to navigation or not. Just like you cannot use docking lights in normal operation of

your boat the intensity of the light would be a factor.

#### What about reflectors?

We highly recommend reflectors on any swim raft although that are not legally required. If your negligent placement or conditions of swim raft cause damage or injury you could be civilly or criminally liable.

# How far out can my swim raft be and where can I anchor it?

There is not a specific distance out your swim raft can be just keep in mind it can't be so far out as to interfere with normal navigation of the lake. Think if it's preventing normal leisure activities you should move it back.

**Placement:** The only real rule here is that only riparian

owners can place a swim raft and it must be anchored to YOUR BOTTOMLANDS.

## How far away do boats have to stay from my swim raft?

#### 2 answers:

If operating ABOVE no wake speed 100ft.

If operating BELOW no wake speed there is no guideline.

#### Is there a size limit?

NOPE—as long as you don't interfere with navigation or another riparian's "reasonable use"

## What can be on my swim raft?

ANYTHING! Except a roof and walls basically, than you would require a permit. Slides, trampolines, couches, TV's in-laws all OK!



## Recreation Passport Reminder This is a reprinting from Fall Newsletter for anyone who may have missed it

# Recreation Passport now required to access any state owned boat launch.

In 2019 you may have noticed the new sign requiring a recreation passport at the boat launch area. In speaking with the DNR on this 2019 is an education year but enforcement action will start next year 2020. Technically this means you cannot launch your boat without it or park onsite etc.

#### WHAT THE RECREATION PASSPORT IS

Michigan's Recreation Passport is your key to:

- Visiting more than 100 state parks and recreation areas.
- DNR boating access sites (or boat launches).
- Parking for rustic forest campgrounds and hundreds of miles of trails.
- Attending free family outdoor events and classes.



MICHIGAN RESIDENTS: You can get this with your license plate renewal. It shows on the sticker. It's \$11/year and then you get statewide access to any boat launch, state park etc. If you purchase NOT WITH YOUR ANNUAL RENEWAL its \$16 at a state park, office or online.

NON RESIDENTS: Annual non resident fee is \$33 the daily is \$9 You can purchase this online at Michigan.gov estore (search in google)

#### Michigan's Fishing License Review

You must purchase a fishing license if you are 17 years of age or older to fish. If you are under 17, you may fish without a license, but you are required to observe all fishing rules and regulations. Any adult actively assisting a minor who does not have a license must have a fishing license. Please note, a license is required when targeting fish, amphibians, crustaceans and reptiles.

Michigan's annual fishing license is valid from March 1 of a given year through March 31 of the following year.

#### FISHING LICENSES - ALL-SPECIES FEES

- Resident Annual \$26
- Nonresident Annual \$76
- Senior Annual (Residents 65 or older or residents who are legally blind) \$11
- 24-hour (Resident or Nonresident) \$10
- 72-hour (Resident or Nonresident) \$30

A new tradition?


#### An invitation from the President:

# What are the "rights" of riparian owners in Michigan?

To explore this one let's first answer what a "riparian owner" is. Simply put a riparian is someone who owns property on a bank or shore of an inland lake or stream.

We should probably start by saying none of this is legal advice and Only a court can adjudicate any disputes you may have. Take this As a general resource for riparian rights and their limitations as

Well. History is this area has taught us that the definition and scope of many of these rights changes often.



#### **BASIC RIGHTS:**

- Access to the water of an inland lake or stream upon which they own riparian property
- Installation of a dock anchored to his riparian bottom land
- Anchorage of a boat on his bottom land and/or secure mooring to his dock
- Reasonable use of water from the lake or stream for strictly domestic purposes
- The right of accretions; meaning the ownership of the gradual accumulation of sand, silt or organic matter on riparian owned shoreline.

#### Thing you can't do..

- Anchor a raft or moor a boat on or above the bottom lands of another riparian owner
- Install a dock of an unreasonable length and/or at an angle that interferes with or limits the navigability of the water body or the riparian rights of neighboring property owners
- Dedicate the surface or any portion thereof of a lake or stream without a permit from the DEQ
- Transfer riparian rights to another person •
- Restrict the use of the surface of a lake or stream by members of the public
- Build a seawall or jetty closer to the water's edge than at the ordinary high-water mark
- Construct a seawall without a DEQ permit
- Dredge or place fill in a lake or stream without a permit from the DEQ

Alter or modify their riparian shoreline or remove aquatic plants without a DEQ permit


#### **FAQs**

#### Can I walk the shoreline as long as I don't go past the "high water mark"?

Some people misinterpreted the ruling on this matter a few years back. In that ruling the Supreme court ruled that was legal for the GREAT LAKES. It does not apply to inland lakes. Simply put no you can't without permission. However you could swim in the water right along the shoreline..

#### **Public Rights to Fishing and Mooring?**

The public has the right to enjoy the water of the lake equal with the rights of riparian including fishing, swimming and recreational boating. Anyone can temporarily moor (anchor) their boat for those purposes, however overnight mooring is limited to riparian owners. The public can fish anywhere on the water including right next to your dock, if you have a concern about safety or someone potentially damaging your property we suggest you just talk calmly with them, in general our visitors and neighbors are very respectful and reasonable!

EGLE permitting restrictions, national holidays, and/or weather conditions may influence the timing of treatments throughout the 2020 season. PLM treats each lake according to a schedule or season plan, established with the cooperation of your lake association, lake board or residents on the lake. The treatment schedule is approximate. Please watch your shoreline for the posting of the 8.5x11 inch, yellow or green signs. The signs will indicate the date of the treatment, the products used, and any restrictions on the use of treated water for swimming, watering lawns, etc.

The property owners in this area are planning to have the waters chemically treated to control lake weeds and/or algae. This notice is being circulated in accordance with Department of Environment, Great Lakes and Energy (EGLE) procedures. Below is a list of herbicides that <u>may</u> be applied to the lake and the associated use restrictions. On the day of treatment, signs will be posted along the shoreline within 100 feet of treatment areas that indicate what products were used and specific water use restrictions that apply:
